Replacement of Lost or Damaged Keys

Covers the replacement and/or reprogramming of the covered vehicle key/remote if lost or damaged, up to \$800 per occurrence.

Lockout and Towing Assistance

Covers 24-hour vehicle lockout assistance, up to \$100 per occurrence. If the vehicle key/remote is lost, damaged, or stolen, towing assistance will be provided to the nearest registered service facility, up to \$100 per occurrence.

Substitute Transportation Reimbursement

Covers taxi, rental vehicle, or public transportation reimbursement, up to \$75 per occurrence.
